The main purpose of the **INRI** is the research related to all EMF events. The purpose of **INRI**, or the Independent Narrative Research Initiative, is to organize, fund, and publish scientific reports and above all “popular EMF science” in order to try to reach out with solid research to a much wider public of “EMF 5G vs. the VIRUS narrative”, and to work to get accountability for all the damage, and to promote stronger restrictions of all EMF, 4G / 5G technology in particular, to enhance the safety of all humans and biological life on earth.

1. Organize research. The **INRI** shall work to organize, to establish, and to build, a unique science team, to research how EMF, like VLF, 3G, 4G, and 5G, microwave, may cause damage, and much more combined with Graphene Oxide. And maybe the cause of a substantial radiation damage to cells and organs, of humans, animals, birds, insects, plants and trees, and all biological life. This may not only explain the „Covid19 disease”, but also suggests that earlier EMF incidents, may have caused diseases and an enormous amount of excess mortality. And to link the science to unique new sets of **INRI** Research data, of massive excess mortality in the USA, Canada, Norway, Sweden, Denmark, England, Wales, Scotland, Northern Ireland, Ireland, 50 counties of California, and Switzerland, (++) , correlated to EMF events. And finally, to show all the facts from the historical record of EMF events correlated to diseases from 1860–1889, all the way until now.

2. Funding of research. **INRI** shall make an effort to obtain funds from private and independent sources of finance to fund the publishing of research reports, *and transform research more to „popular science”* to reach a much wider audience, and to fund new research into EMF issues. And to suggest what may have been a major cause of the excess death in 2020 before the C19 Vax, and a major confounder of the excess death in 2021, and 2022 and earlier „virus pandemics”.

3. Publish research. **INRI** will establish a website, a Substack blog, and *publish books* linked to the INRI Organization, and get book licences from EMF authors, as a resource for communication. To communicate all evidence and documentation of EMF, 3G, 4G, 5G, and other EMF related to excess death. And likely to be the cause of diseases such as Long Covid, cancer, heart diseases, and a huge increase in many chronic diseases including acute radiation illness. And to work to share EMF research as „*popular science*” on *social media platforms*, and *via alliances*, to the *alternative media*, and, if possible, to get the MSM in it, too. Finally, to engage directly to get EMF research into the domain of the public, politicians, and big corporations, of „*the not so safe EMF*”.

4. To promote much stricter EMF regulations and alternative technologies.

INRI calls for a moratorium and much stricter regulations for 4G, 5G / EMF for the protection of all biological life.

5. To suggest non-medical protocols and ways to avoid much of the harm caused by EMF.

INRI shall refer to and inform about a common sense approach, based on peer reviewed mitigation protocols, and advice from the most renowned EMF research specialists and historical research.
